Discussion held regarding two grants that were awarded to the Milligan Rescue Unit. One is an equipment grant, that includes the radios that need to be upgraded, and the other is a grant towards a new rescue unit. The general consensus of the board was to accept the grants.

Correspondence was read and discussed. Included was the annual franchise fees received from Black Hills Energy and the 4th quarter lease payment from Perennial Public Power District.
